

## INFANT BAPTISM BY SPRINKLING

Infant baptism is simply not Biblical, it is Satan's invention to make people believe that they are on their way to heaven.



Baptism is well known and recognized as a "regeneration" of ones self in the Romish church and many others. This same regeneration concept is used also for holy water. To the Roman Catholic church, baptism is "of absolute necessity for salvation", insomuch as even infants dying without it cannot be admitted to heaven. When the Roman Catholic priest talks about infant baptism, he explains to the parents of the innocent child that baptism is absolutely necessary for the child's salvation, and if the baby isn't baptized, it simply cannot go to heaven. Unknown to the parents, the ancient Satanic ceremony of sacrificing the babies to Baal using oil and salt, will now be applied to their child, exposing this innocent baby to the secret agents, demons of Babylon and Satan.

The priest claims he must exorcise the baby of demon forces to protect it. He then puts the occult mark of Tammuz on the babies head with oil (the sign of the cross). Then he puts salt in the baby's mouth and the child is baptized with water. The baby then becomes a member of the Great Babylon religion of the Vatican. At this point the baby is supposed to be cleansed from all original sin, and made a child of God, and heir of heaven. The baby is then classified

as "born again". The indelible mark on this babies soul is Satanic. A famous Bishop Hay of Rome when asked the following question; what happens to a child who dies without baptism? replied; "if a young child were put to death for the sake of Christ, this would be to the baptism of blood, and carry it into heaven; but except in this case, as such infants are incapable of having the desire of baptism, with the other necessary dispositions, if they are not actually baptized with water, they cannot go to heaven". This statement is from the mouth of the serpent himself. This of course is unscriptural as per "Suffer the little children to come unto Me, and forbid them not; for of such is the kingdom of heaven", written in our good Book. The practice of making the form of a cross on an infants forehead is also from the pagans. The cross form, called the Tau, was the symbol used by heathens of old in their rituals.

The true Hebrew meaning of Biblical Baptism meant that the “old Adam was washed away and the new man was brought forth”. This is not regeneration, it is what you might call “born again” from the womb. This Mikvah meant that you were completely re-born, and therefore the immersion in water represented the mothers womb. True “People of the way” Baptism, was used for repentance, and for having the old Adam washed away, not like the heathens.

In the Babylonian practices, baptism took place for initiates into the mysteries of the gods and goddesses. The Chaldean pagans required baptism for initiates prior to any instruction being received. Children were baptized into the worship of Osiris, Odin, Isis, Mithra, etc., without ever consenting to it.

Regardless of what many have believed, Baptism in the scriptures was only for those who did so voluntarily; never were Believers infants baptized, for obvious reasons. The practice of baptizing infants was/is of pagan origin.
